1. Application fee includes State Government Levy (0.128%) for works over \$10,001 in value - check with our office.
2. For building permits with a cost of works over \$5,000, a cheque or additional payment of \$33.30 will be required to cover the lodgement with Relevant Councils.
3. For a building permit to demolish a structure/building please check with our office.
4. Application fee's can be paid via cheque, cash, electronic fund transfer or credit card (2% surcharge will apply)
